STAIR Marks 25 Years of Service

Marking its 25th anniversary in 2010, STAIR continues to be a successful children’s literacy program in the Greater New Orleans area providing free one-on-one after school tutoring in reading and language skills to at-risk second-grade public elementary school students as well as literacy support to family members. Founded in 1985, STAIR has brought more than 300,000 hours of dedicated volunteer service to its partner public schools to help nearly 6,000 New Orleans area students excel. As it has been for 25 years, STAIR is led by a strong all-volunteer Board of Directors and Advisory Council, staffed by qualified literacy administrators, and endowed with a volunteer force of more than 350 trained community individuals.



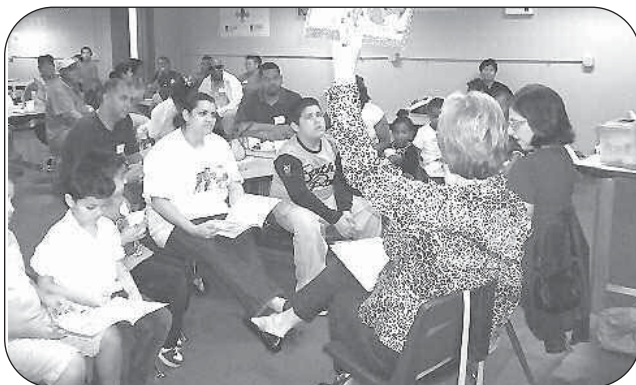

STAIR Facts 2009-2010

- 238 students served
- 29 tutoring sites in Orleans, Jefferson and Plaquemines parishes
- 350+ volunteers
- 33 public schools
- Oral reading fluency on DIBELS test increased nearly 92%
- Of the STAIR parents who returned surveys, 100 % reported that their children’s reading skills have improved, 88% said their children were much more interested in reading, and 73% said that helpful tutors made the difference.

sponsored by the Louisiana Endowment for the Humanities: In previous years, STAIR has coordinated the six-week Prime Time program of reading, discussion, and storytelling for children and family members from Dibert Elementary School and Esperanza Charter School. STAIR will conduct this program at Capdau UNO Charter School in the fall of 2010 and at another public elementary school in the spring of 2011.

STAIR'S Partnerships: STAIR's tutoring sites are located at its partner schools, universities and various churches that donate storage space for curriculum materials and books as well as classroom space for tutoring. STAIR has partnerships with local universities as part of their work-study or service-learning programs, including Dillard, UNO, Xavier, Loyola and Tulane.

STAIR also continues to work with its partners New Orleans Kids Partnership, Connect2Educate Collaborative, Communities in Schools-New Orleans, New Orleans Musicians Assistance Foundation, Greater New Orleans Afterschool Partnership, Literacy Alliance of Greater New Orleans, First Book-Greater New Orleans and the Unified Nonprofits of Greater New Orleans.
